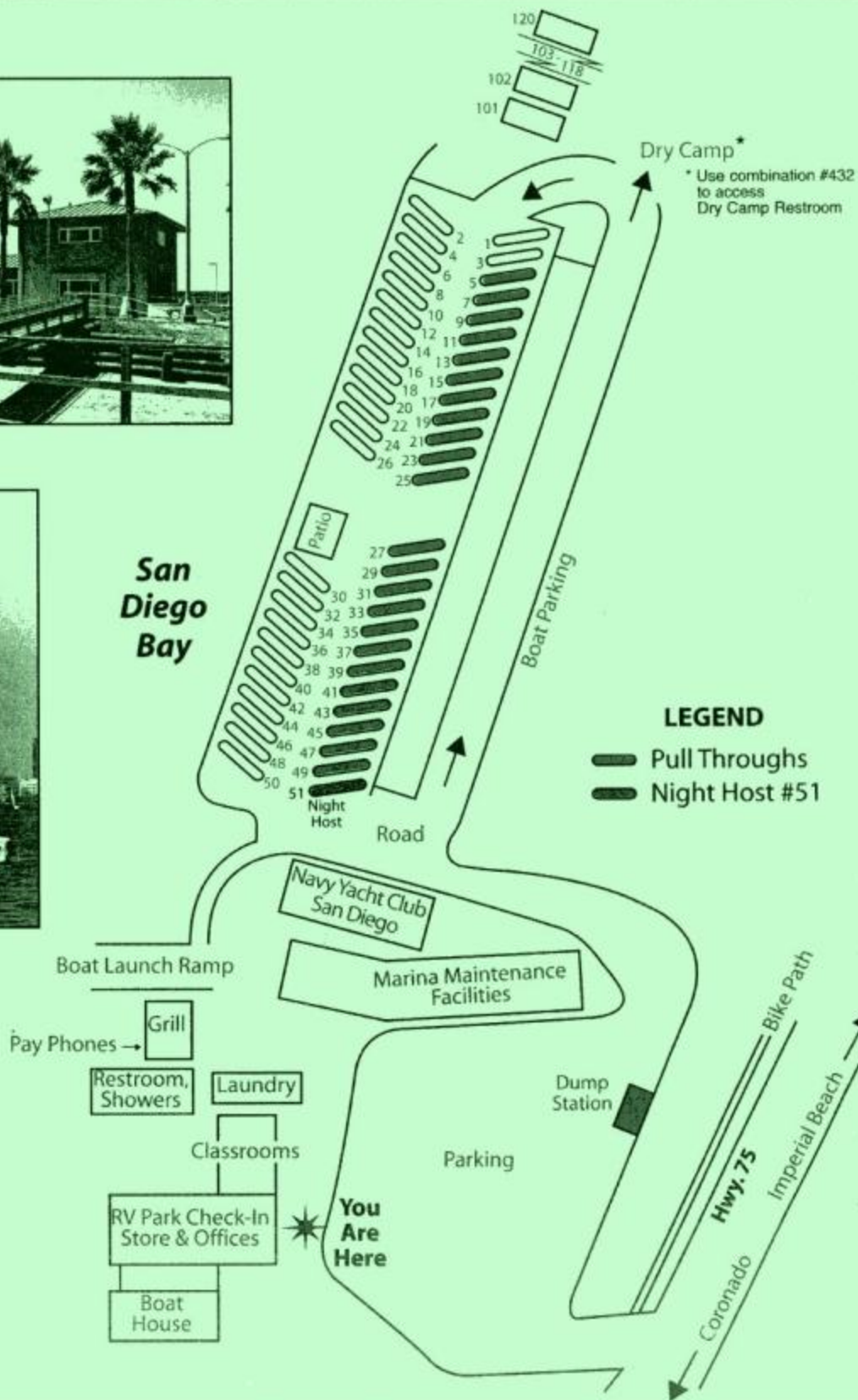

Before occupying any area of the RV Park you must register at Park Office during office hours. If you arrive after hours see the Camp Hosts in Site 49.

VALID MILITARY IDENTIFICATION IS REQUIRED!

1. The following people are eligible to use Fiddler's Cove RV Park: Active Duty and Retired Military personnel; U.S. Military Reserve components; Active and Retired DOD employees; and U. S. Coast Guard personnel. **MILITARY IDENTIFICATION WILL BE REQUIRED TO VERIFY ELIGIBILITY.** An eligible RV may sponsor one guest RV. The authorized sponsor must make the reservations, register their guest, and remain on the premises in their own RV during the entire stay. Sponsors must be present and checked into the Park in their *own* RV prior to the arrival of their guest's RV. RV sponsors must be 18 years of age have Military ID and valid drivers license appropriate for the size of the RV. Sponsors are responsible for the safety and conduct of their dependents/guests, and will be held financially responsible for any unpaid fees and/or damages brought about by their dependents/guests. **Authorized Patrons are not permitted to sponsor other authorized patrons as Guests.**
2. The size of a Recreational Vehicle and dates of stay determine site assignments. **Management will not guarantee specific site requests;** however, we'll try to accommodate you upon arrival. An RV is defined as a registered and licensed self-contained vehicle designed to be lived in. Acceptable examples are: self-propelled class A/C motorhomes; travel trailers (hitch or 5th wheel); class-B factory converted camper-vans; and pick-up truck mounted self-contained campers. SUVs, pick-ups with shells, commercial tractor-trailer rigs and non-factory converted vans are not considered RVs and will not be eligible to rent an RV site. Do not change sites without prior approval from the reservations desk or Night Host. Reservation cancellation requires 24 hours notice to avoid being charged for 1 days rent. Early departure requires 24 hours notice for refund. Patrons failing to vacate their RV site by checkout time will be charged an additional days rent. The RESERVATION CARD issued by the Park Office must be displayed in the clip on the utility box in hook-up sites or site marker in Dry Camp.
3. Length of stay: During the peak season (1-May thru Labor Day weekend) reservations may be made for a maximum of 30 days. During the Fall/Winter season (mid-Sept. to 30Apr), one 14-day extension may be granted if space is available. The extension cannot be included in the original reservation and cannot extend into the Peak Season. Patrons may be subjected to relocation for the extension period. Patrons must vacate the RV Park for a minimum of 14 days after each maximum stay limit has been reached.
4. The speed limit in the RV Park and Marina parking lot is 5-Miles Per Hour (MPH). SAFETY FIRST!
5. a. Park your RV in your assigned site so it does not block the paved East/West ingress and egress road. This road is the primary access road for emergency and service vehicles in and out of the RV Park. Like wise, do not park your secondary vehicle or boat so that they block the ingress/egress road.
Do not park your secondary vehicle or boat in any unoccupied site. Guest parking is located in the main lot.
 - b. **Bayside sites:** Utilities (30amp electrical / fresh water) will be on the left side of your vehicle when it is backed in. If you choose to nose your vehicle into your site you must have enough electrical cord and water hose to traverse under your RV. The wheels of your RV must remain on the concrete slab provided for your assigned site. RVs/Trailers that back into a site will have priority for awning use. Awnings should not extend over the power pedestal. Do not park tow vehicles, tow dollies, gear trailers or boat trailers on the beach, forward of the utility pole or in a position that it will block or impede your neighbor's access to their space or RV.
 - c. **Pull thru sites:** you may enter the space from either direction as long as your RV or trailer/trailer tongue is as close to (but not over) the red Fire Lane line. The wheels of your RV must remain on the concrete slab provided for

your assigned site. Oversized RV's may have one set of wheels on the gravel. Parking for tow/towed vehicles is on the gravel behind the concrete pad. Awnings should not extend past the utility box.

- d. **Dry Camp Sites 100 through 118:** Water and electricity is not provided. RVs will park so that the front/back of the RV is perpendicular to the front of the designated space; RV's are not allowed to park parallel to the shore/beach front. You may have one RV with one tent per site with a maximum of 8 persons per night. Tent camping is permitted only in Dry Camp spaces; you may pitch two tents per site with a maximum of 8 persons per night. Tents are not allowed on the beach side of site marker poles. Do not park tow vehicles, tow dollies, gear trailers or boat trailers on the beach forward of the marker pole, or in a position that it will block or impede your neighbor's access to their space or RV.
7. **Sleeping in cars, non-factory converted Vans or the beds of pick-up trucks is prohibited thru-out the RV Park.**
8. Quiet hours are from 2200 to 0800 (10pm-8am). No excessive noise is allowed at anytime. Generators must be off from 2200 to 0800 (10pm-8am). Please be considerate of your neighbor.
9. Black/Grey water must be dumped only at the designated dump station. The dumping of any sewage will be considered a HAZMAT spill and applicable laws and fines will be enforced. Run off of any kind will not be permitted.
10. **The washing of RV's, and cars is not permitted in the RV Park.** Washing of boats is permitted only at the dump station. **RV, vehicle/ boat maintenance is not permitted in the RV Park.**
11. The area around your RV must be kept clean and orderly. Daily inspections are made to ensure that sites are being kept neat and orderly. You will be advised to remove excess clutter. Clotheslines are not permitted. Trash will be placed in proper receptacles and not permitted to accumulate around your RV site. Hazardous waste must not be placed in the trash receptacles at Fiddler's Cove. See facility personnel for assistance with the proper disposal of hazardous waste.
12. **CAMP FIRES ARE PERMITTED IN PROVIDED FIRE RINGS ONLY.** Portable, open flame producing (wood, gas or electric) campfire pits / chimnias etc. are not authorized. Fire rings are located on the beachfront. All firewood to be burned must be stacked inside not on top of the fire ring. Wood must be free of any kind of chemical coatings, paint, varnish, and/or marine anti-fouling coatings. Pallets must be broken up to fit inside the rings, not stacked up on top of the rings. Fires must be supervised at all times and completely extinguished before users depart the fire-ring area. Fire rings are not to be used as trash receptacles.
THERE ARE NO EXCEPTIONS to these Naval Base Coronado Federal Fire Dept. regulations!
13. **FIREWORKS ARE PROHIBITED.**
14. **THERE ARE NO LIFEGUARDS ON DUTY:** wading in the Marina/RV Park is at your own risk. Swimming is not allowed.
15. **The operation of ATV's, or any off-road "sand-toys" or off road motorcycles is prohibited in the RV Park and adjacent beaches.** Also Mini-bikes and "pocket" motorcycles are not allowed to be operated in the RV Park.
16. Gas powered Remote Controlled cars/boats are not allowed. Battery powered RCs maybe used on the beach, in the Dry Camp or in the water.
17. Fishing is permitted from the Beach only, not from the Pier or Dock. A California State fishing license is required.
18. **PETS:** (dogs, cats, etc) will be leashed and under the direct control of their owners at all times. Leashes are limited to 6 feet in length. If you intend to tether your pet to your RV, the tether must not permit the pet access to the adjacent RV site or permit the pet access to the main ingress/egress road. Ensure your pet is quiet and not left unattended. Loud or aggressive pet(s) will not be tolerated. All pets must have their current shots and registration. A fenced dog run is located at the northwest corner of the facility. Pet owners are responsible for picking up and disposing of their pet's droppings in all areas of this facility.

Failure to comply with park rules could result in termination of stay without refund.

FREQUENTLY ASKED DIRECTIONS

WALMART DIRECTIONS:

TURN LEFT ON HWY 75 TOWARDS IMPERIAL BEACH (6 MILES). HWY 75 TURNS INTO PALM AVE. STAY ON PALM AVE (3 MILES) PAST 805. TURN RIGHT AT THE FIRST LIGHT AFTER HWY 805 INTO THE SHOPPING CENTER.

NORTH ISLAND NAVY EXCHANGE/COMMISSARY:

TURN RIGHT ON HWY 75 TOWARDS CORONADO. TURN LEFT ON THIRD ST. TURN RIGHT ON ALAMEDA BLVD (WHERE THIRD ST. ENDS). LOOK FOR A DRIVEWAY NEAR 2ND ST LEADING TO THE NEX GAS STATION ON THE LEFT AND TURN IN AT GAS STATION. EXCHANGE/COMMISSARY IS BEYOND THE GAS STATION.

32ND STREET NAVY EXCHANGE/COMMISSARY/CAR & RV WASH:

TURN RIGHT ON HWY 75 TOWARDS CORONADO. TURN RIGHT ON FOURTH ST. AND CONTINUE OVER THE BRIDGE. VEER RIGHT AT THE END OF THE BRIDGE TO 5 SOUTH. TAKE THE 28TH STREET EXIT - NOT THE NATIONAL ST EXIT! THE EXIT WILL FORCE YOU TO TURN RIGHT. GET IN THE LEFT LANE AND GO THROUGH TWO STOP LIGHTS. LOOK FOR ENTRANCE ON THE LEFT AFTER YOU PASS THE EL POLLO LOCO RESTAURANT. IF YOU GO OVER THE TRACKS YOU HAVE GONE TOO FAR.

TURN LEFT ON HWY 75 TOWARDS IMPERIAL BEACH. HWY 75 TURNS INTO PALM AVE. TURN RIGHT ON 13TH ST. 13TH ST DEAD ENDS AT THE GATE. ENTER THE GATE, THE STORES ARE JUST PAST THE GATE.

BUS STOP:

LEFT AT THE MAIN ENTRANCE TO MARINA, FOLLOWING THE BIKE PATH TO LEYTE ROAD (TRAFFIC LIGHT). THERE IS A BUS STOP AT THE TRAFFIC LIGHT LEYTE ROAD AND HIGHWAY 75.

TROLLEY TO TIJUANA:

TURN LEFT ON HWY 75 TOWARDS IMPERIAL BEACH. HWY 75 TURNS INTO PALM AVE. PASS HWY 5, GO OVER THE TROLLEY TRACKS, AND THE TROLLEY STATION IS ON THE LEFT.

GAS, DIESEL FUEL AND PROPANE:

MCRD base has gas, diesel, and propane for sale.

32nd Street has gas and propane at their off base gas station.

ADDITIONAL PARKING FOR REGISTERED PATRONS.

For registered Patrons of the RV Park, there is additional parking in the following areas. First come first serve.

At the entrance to the RV Park in the gravel off the service road there are two (2) spaces. (Not behind the Motorhome parked in Site 49.)

Beside the RV Park Patio (in the gravel) there is space for three (3) vehicles.

Across from the Patio (in the gravel) there is space for four (4) vehicles, two (2) are reserved. There are four (4) spaces off the service road.

At the end of the Park (entrance to Dry Camp) there is space for eight (8) vehicles.

PLEASE DO NOT PARK IN UNAUTHORIZED PARKING SPACES.

Reminder to registered Patrons/Sponsor. Guest parking is in the main parking lot.

Regulations

Speed Limit is 5 MPH.

Dogs must be on a leash, cleaned up after and not left outside RV unattended.

No vehicle may be washed at Fiddler's Cove. Washing of boats must be done at dump station only.

Tents are only allowed in the dry camp area.

Fires are permitted along the waterfront sites only. We reserve the right to forbid fires we deem unsafe.

A 24-hour notice is required for a refund if you are planning an early departure.

Quiet hours are from 10 p.m. to 8 a.m.

There is no swimming in the Park.

A detailed list of rules is located in the RV Park Office.

Policies

Fiddler's Cove RV Park and Marina allow pets on the premises, however, pets must be on a leash and patrons are asked not to leave pets unattended, outside of their vehicle. Patrons are also asked to clean up after their pet. Tents are allowed in the dry camp area of the RV Park and fires are permitted along the waterfront sites.
